This Request for Expressions of Interest follows the General Procurement Notice (GPN) for this Project which appeared in **Zanzibar Leo Issue No.1821- 8555 - 5790** dated 13<sup>rd</sup> June 2020.

Zanzibar Utilities Regulatory Authority has set aside funds for the operation during the financial year 2020/2021, and intends to apply part of the planned budget amount for payments under the contract for the **“Consultancy Services for the Development and Deployment of Integrated Procurement and Accounting Management System Software for Zanzibar Utilities Regulatory Authority (ZURA)**

- i. The objective of the assignment includes services but not limited to develop a comprehensive Integrated Procurement and Accounting Management System Software to support effective Enhancing management control and improving accountability for decision- making throughout the procurement and accounting divisions on matters related to utilities procurement and accounting processes.
- ii. Enabling information exchange and sharing among selected Government Authorities and Departments in authoritative and efficient manner.
- iii. To Automate and streamline reporting, develop advanced modelling and support data mining and to accurately see summarized, timely information used for decision-making and financial reporting.
- iv. To facilitates the process of obtaining the necessary materials and services in every step of the way, users can view and access information regarding costs, expenditures, goods and suppliers.
- v. To develop standard procedures and guidelines for maintaining the Software, and the integrated system. The consultant will also be required to build capacity within ZURA to use and maintain the developed system.

The duration for the implementation of this assignment is Three months (3) from the date of Signing of the Contract.

Zanzibar Utility Regulatory Authority (ZURA) now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may constitute joint-ventures to enhance their chances of qualification.

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the requirement of Public Procurement and Disposal of Public Assets Act No.11 of 2016, Rules and Procedures for the employment of Consultants.
