

**THE ZANZIBAR UTILITIES REGULATORY AUTHORITY**

**NOTICE OF INVITATION FOR NOMINATION OF MEMBERS OF THE  
CONSUMER REPRESENTATIVES COUNCIL (CRC)**

**1. Background**

The Consumer Representatives Council (CRC) is a consultative council established under Section 33 (1) of the Zanzibar Utilities Regulatory Authority (ZURA) Act No. 7 of 2013, for safeguarding the interest of the consumer of the services regulated by ZURA which are water, electricity, petroleum and gas.

In pursuance of provision of Section 33(2) of the ZURA Act of 2013, the Minister for Water, Energy and Mineral invite Organization legally recognized as being representative of private sector interest to submit list of persons for nomination of members to Consumer Representatives Council (CRC) to represent the interest of consumers of water, electricity, petroleum and gas.

**2. Responsibilities**

The Council shall have powers and perform the following functions, namely:

- (a) to represent the interest of the consumers by providing information and opinion to Authority, Minister and regulatory sector subject to the Zanzibar Utilities Regulatory Authority Act, No. 7 of 2013;
- (b) to receive and supply information and opinions relating to the interest of consumers in regulatory services; and
- (c) to consult with the industry owners, government and other group of consumers relating to the problems of the interest of the consumers of the regulatory services.

**3. Qualifications Required**

Each of the said Organization, urged to submit list of persons who have knowledge and understanding of the interests of consumers and that of the regulated services under the said Act and in particular have the qualifications as hereunder stated:

- (a) to have at least a degree in public administration, business, law or engineering in the field of petroleum, electricity, water or any other related field from a university recognized by the Revolutionary Government of Zanzibar;



- (b) to have knowledge and experience of not less than three years on regulated utilities; (water, electricity, petroleum and gas);
- (c) to have knowledge and understanding of the interest of the consumer;
- (d) to have high integrity;
- (e) not to be a political leader of any political party;
- (f) shall be from organization legally recognized to represent private sector and which have knowledge on the consumers interest and regulated services; and
- (g) shall not have a conflict of interest to any party among the stakeholders of the Zanzibar Utilities Regulatory Authority.

#### **4. Deadline for submission**

Nominations should reach the undersigned within three weeks from the date of the first appearance of this publication.

#### **5. Mode of application**

- 5.1 Nominations for the Consumer Representatives Council (CRC) should be made in writing and should include the name of the organization, name of the nominated person and name of the person making nomination; enclosing detailed Curriculum Vitae (CV) and certified copies of relevant certificates.
- 5.2 The CV should include names, addresses, telephone numbers and e-mails of three references.
